2019.055 Woodlands Reports

Dot Hull, the chairperson of the Trustee Directors, has spoken about the Woodlands. Financially they were solvent again these last two years but Dot warned us of the crisis in care throughout the country. Next year will be the 75th year of the Woodlands.

The Woodlands do struggle with finance from the local authority although Wolverhampton local authority do recognise they are an excellent home. This is due to the commitment of all the excellent staff.

We need more Quaker trustees as they are at their minimum number. Care of the Elderly is a long standing concern of this Area Meeting.

Trustees do need to keep abreast of changing Health and Safety matters, infection prevention and associated regulations; but Dot assured us it is possible to learn.

Interested Friends could be co-opted to serve on the management committee, not as a trustee, for a year to introduce them to the knowledge and skills required.

There is still a Meeting for Worship twice a month supported by Stourbridge and Wolverhampton local meetings.

The reports for 2017/18 and 2018/19 are filed with these minutes. We thank Dot Hull and the other trustee directors and the staff of the Woodlands for providing a Quaker environment and care for the residents at the home.

2019.056 QPSW Spring Conference Report

Donald Whitlock has spoken enthusiastically to his written report on this conference where the theme was inclusion, diversity and privilege. He was inspired by the activists he met.

He appreciated the inspiring, uplifting keynote speech by Nim Njuguna. The workshops he attended were not his first choices but the Action for Peace workshop was enlightening and he told us he feels that he might now be able to attend the DSEI demo with some Friends from Solihull Meeting later this year.

We thank Donald Whitlock for attending the conference on our behalf and the report is filed.

2019.057 Update from Low Carbon Commitment Forum

At last Area Meeting (minute 2019.045 refers) we agreed that the clerk should sign the faith leaders letter to Birmingham City Council and we are pleased to hear that Birmingham City Council have now declared a Climate Emergency.

We recognise that this is just a first step and more work needs to be done.

We thank our Low Carbon Commitment Forum for the update report on this, filed with these minutes, and ask them to work with Friends and other faiths in other council regions across the West Midlands and Warwickshire and also ask them how our Area Meeting can contribute in the Birmingham area.

2019.058 Minute Received from Stourbridge LM

We have received Stourbridge's minute 57/19:

Following a performance of a Rock and a Hard Place on 27th April, three Stourbridge Friends met representatives of two women's aid organisations - Black Country Women's Aid (BCWA) and West Mercia Women's Aid (WMWA). It was agreed that we would ask for some financial support to be provided from the Area Meeting Black Country Fund to help these organisations. According to CEQ guidelines on the correct application of charitable funds, this proposal needs to be accepted as a concern by a Local Meeting, then forwarded to Central England Area Meeting. We are pleased to adopt BCWA and WMWA as a concern of this Meeting.

The BCWA is hoping to have a new extension built and this would need furnishing; their estimate of the cost is £1000 per room. We would ask Area Meeting to donate £2000 from the Black Country Fund. This agreement will allow us to donate to West Mercia Women's Aid and other similar organisations in the future, should we wish to do so.

We ask our clerk to send this minute to Area Meeting.

We understand from Trustees Finance committee that there is money available in this fund, and as this is a LM concern we are happy for money to be granted as requested.

We refer the matter back to Finance Committee for implementation.

2019.059 Investment Update and Revised Investment Policy

Further to our minute 2018.123 at our December 2018 Area Meeting, we are returning to the concern raised by Walsall Meeting.

We have received no minutes from Local Meetings on this matter.

Local Meetings have discretion to invest where they think fit, but should take advice as appropriate.

Our Trustee Finance Committee are still recommending that Meetings use the Churches, Charities and Local Authorities (CCLA) COIF Ethical Fund.

We note that Walsall's concern has not gone away, as the COIF ethical fund can be invested in companies that have a very small percentage in areas we would not wish to be involved with although it does screen all investments. We acknowledge that this remains a concern to Walsall Friends, shared by other individual Friends.

As a result of Walsall's concern, our Trustee Finance committee have reviewed the Investment Policy. John Kimberley, our investment treasurer, explained our trustees' position in updating the investment policy which now included some advice taken from Britain Yearly Meeting's (BYM) investment policy, where trustees have obligations which may constrain them more than as individuals. The new version (revised May 2019) is accepted. We are reminded that this policy is a work in progress and further revisions may occur.

We welcome trustees' recommendation to change brokers, in due course, to Rathbone Greenbank Investments, an ethical investment broker, who also manage BYM investments.
