## **2019.019 West Midlands Quaker Peace Education Project (WMQPEP) Peacemakers: future vision**

At our meeting in January we agreed to return to explore the direction of work and shape of Peacemakers, as recorded in minute CEQ/2019.005.

Also in our papers today, we have a record of the discussion at WMQPEP Management Committee held on 24.01.2019; and a paper from Sara Hagel, director of WMQPEP, 'Vision for WMQPEP', setting out a possible innovation strategy.

We have heard from many Friends during our discernment of this matter and the overwhelming feeling of the meeting is that we wish to support and encourage Peacemakers in pursuing the vision for expanding their work into the community.

It is also important to Central England Quakers that the work in schools should continue, though we realise that school budgets are stretched and we may have to look at more financial support for this area of Peacemakers work.

The West Midlands Quaker Peace Education Project is a long-established branch of Central England Quakers: its work and achievements are valued and supported by individual Friends and the Area Meeting, and indeed are nationally recognised. We want to be sure that the Quaker values and ethos of the organisation remain strong.

The erosion of youth services and the rise in knife crime are areas where Peacemakers can make a difference. We feel though that it is important to ensure the work remains local, to build on and use effectively the skills and knowledge of the Peacemakers staff.

We ask the WMQPEP Management Committee to consider this in more detail and bring a costed proposal to a future Area Meeting.

## **2019.020 Community Justice Group Terms of Reference**

We have received the reviewed TOR from our Community Justice Group, but we find some inconsistencies in the document, and ask the CJG to look at it again. In particular, is it a Group or a Committee? And is it really necessary to limit the number of Friends who may be involved?

## 2019.021 Quaker Christmas Parcels Report

We have received a written report from QCP committee and John Ironside has spoken to it.

We are well aware of the need for this project and are pleased to hear that Notts and Derby Area Meeting are interested in setting up a similar scheme.
