Minutes of Central England Area Meeting of the Religious Society of Friends (Quakers) held at Bull Street Meeting House and online on 28 January 2023

2023.001 Opening worship

We have started our meeting with a period of stillness during which we heard of the death of our Friends Marian Singles, (SOL) 21 November 2022, aged 90; Marcus Marcussen, (COT), Tenbury Wells, 27 October 2022, aged 99; and Francis Rowland Dale, (SEL), 8 January 2023 aged 88. We also heard *Quaker Faith & Practice*? 3.05 as follows:

The right conduct of our meetings for church affairs depends upon all coming to them in an active, seeking spirit, not with minds already made up on a particular course of action, determined to push this through at all costs. But open minds are not empty minds, nor uncritically receptive: the service of the meeting calls for knowledge of facts, often painstakingly acquired, and the ability to estimate their relevance and importance. This demands that we shall be ready to listen to others carefully, without antagonism if they express opinions which are unpleasing to us, but trying always to discern the truth in what they have to offer. It calls, above all, for spiritual sensitivity. If our meetings fail, the failure may well be in those who are ill-prepared to use the method rather than in the inadequacy of the method itself.

It is always to be recognised that, coming together with a variety of temperaments, of backgrounds, education and experience, we shall have differing contributions to make to any deliberation. It is no part of Friends' concern for truth that any should be expected to water down a strong conviction or be silent merely for the sake of easy agreement. Nevertheless we are called to honour our testimony that to every one is given a measure of the light, and that it is in the sharing of knowledge, experience and concern that the way towards unity will be found. There is need for understanding loyalty by the meeting as a whole when, after all sides of a subject have been considered, a minute is accepted as representing the discernment of the meeting.

Not all who attend a meeting for church affairs will necessarily speak: those who are silent can help to develop the sense of the meeting if they listen in a spirit of worship.

2023.002 Representatives

2023.011 Report from Meeting for Sufferings

We have received a report on the recent Meeting for Sufferings from Claire Bowman and she has spoken to this.

She has told us of the tension between YM trustees and Meeting for Suffering and that the situation felt easier after opportunities for discernment in the meeting. We are asked by FWCC to uphold those Friends who are supporting Quakers who live in countries which border on Ukraine and to consider if we might have an active role to play.

We thank Claire for reporting to us today and wish her well in her role on the Meeting for Sufferings Support Group.

2023.012 Report from our Nominations Committee

We have received the annual report from our Nominations Committee. Amongst the items mentioned in the report is the concern for our outreach committee and the difficulty it has had in meeting.

We are grateful for the work that our Outreach Committee has done in the past. We have heard how Stourbridge have approached outreach differently by identifying local opportunities and finding Friends who could cluster informally together to work accordingly. It could be that outreach is really the concern of local meetings, asking nearby LMs for help as needed. Perhaps we could, as an Area Meeting, work on something for Quaker Week this year, considering this at a future Area Meeting. We are reminded that we have an outreach presence in the city in the form of the Peace Hub. The small working group set up last May could be asked to consider outreach matters, perhaps using social media. We hope that we might be able to work with our Local Development Worker on this issue and we are reminded that there are resources which the Area Meeting holds which could be used. We agree to return to this matter at our next meeting.
