But we cannot simply immerse ourselves in these activities. We need to develop our own unique social witness, in obedience to God. We need to listen to the gentle whispers which will tell us how we can bring our lives into greater harmony with heaven.

2023.034 Membership matters

2023.035 How the Truth has prospered in our Local Meetings

Each year we ask our Local Meetings how the Truth has prospered amongst them. These returns are used to form part of our annual report to the Charity Commission. We have now had the opportunity to look through these as an Area Meeting and Claire Bowman has introduced them to us. We are encouraged and inspired to hear of some of the work which is happening in our local meetings, especially as Friends re-build their communities after the pandemic.

2023.036 Report from our Community Justice Group

We have received a report from our Community Justice Group on their work over the last year. There are currently eight members of this group and they support each other in their various roles. These cover chaplaincy work in prisons, hospitals, and the University of Birmingham, as well as retail chaplaincy, with the police, and work with refugees, asylum seekers and other migrants. We are mindful that this work often involves relating to people in very difficult situations and are very grateful for what our Friends do on our behalf.

2023.037 Conference: Quakers in Criminal Justice

We have received a summary report from Robert Sprake and William Waddilove on the Quakers in Criminal Justice Annual Conference which was held at Hinsley Hall, Leeds, 24-26 February 2023. The three main speakers talked about how we do justice to both victim and prisoner; the work of Leeds GATE, a gypsy and traveller support organisation; and the tragic story of David Oluwale who was hounded to death by two police officers in 1969. There were also opportunities for workshop discussions. We are grateful that our Friends were able to attend the conference and for reporting back to us.

2023.038 Report from Meeting for Sufferings

We have received the report from Meeting for Sufferings prepared by Margot Williams. Claire Bowman has referred to some of the disquiet between Yearly Meeting trustees and Meeting for Sufferings. We thank Margot and Claire for the work they do to represent us on Meeting for Suffering.

We are aware the Yearly Meeting will be held before our next meeting and we uphold all Friends who are able to attend in person or on line.

2023.039 Report from Young Friends General Meeting

We have received a report from Sasha King-Smith who attended her first YFGM in February. We are very pleased to have this insight into the conduct and nature of YFGM, as well as to learn that Sasha feels that her spiritual life has been recharged. We wish her well in her exams and encourage any other Young Friends to send reports to us on future General Meetings.

2023.040 Membership: Call for discernment by Area Meetings

Following a request from Central Nominations Committee to consider current guidance regarding appointing only members to central committees, Meeting for Sufferings commissioned a review. This recommended that we could appoint attenders to such roles. However, consideration of this matter led Sufferings to the view that it wanted to have clarity on the nature of membership first. Not until we have clear understanding of membership would we be able to reach a decision on who can be appointed to central committees. Wishing to consult more widely Meeting for Sufferings has asked us to consider this matter and, in particular, to reflect on the following questions, and report back to them by the end of August this year.

- Why do we have membership?
- What is it for?
- Is it still necessary?
- If yes, what form(s) could it take?

In considering this matter we have been reminded that there can be a deep spiritual aspect to applying for membership, similar in a way to getting married. But we are aware that this pattern is not for all and that there may be geographic or social reasons, particularly amongst young Friends, for not wishing to apply. Membership should not be equated with sitting on committees; we need to make membership meaningful so that Attenders will want to join. The idea that Attenders of long standing (eg for a year) could automatically become Friends, provides food for thought. When we become a member we take responsibility for the Religious Society of Friends, its management and its spiritual life.

We ask our Local Meetings to consider the matter, ensuring that the voices of the young and old, attenders and members are heard, and report back by July Area Meeting. We also forward this concern to our Elders and Pastoral Friends Support Group for their consideration.

2023.041 Update from our Local Development Worker

We have received an update from Hilary Topp, our Local Development Worker in which she has outlined the work she has done so far. She is planning to bring together various people involved in working with families, children and young people and invites interested Friends to be in touch with her. She is also keen to meet Friends through Zoom to chat about what is happening in their AMs and to see if she can support them. She hopes to form a group which will meet four times over six months to explore outreach.

We draw this report to the attention of our Local Meetings and ask those who may be concerned, for instance with families and young people, to make their interest known to Hilary Topp if possible. Jo Hallett and John Sheldon hope to attend the drop in session on 5 June.

We are grateful for this report and look forward to continuing to work with Hilary over the coming months.
