For Quakers, building community means fostering a sense of belonging, connection and shared purpose among Friends. Giving to Quakers in Britain helps us to build and strengthen our community, support diverse projects and promote Quaker values in the world.



Local development work connecting children and families in Scotland

Friends in Scotland can be widely dispersed, and most meetings aren't regularly attended by children. Quaker children and families can feel lonely and unwelcome in adult Quaker spaces, leading them to leave meetings. This is a devastating loss to our faith community.

We've found that residential and weekend events that bring Friends together from across Scotland are a great way to help dispersed children and families feel in tune with each other.

So we turned to our CYP Advocates, who promote the inclusion of children and young people in the life of Quaker meetings. Supported by our local development worker in Scotland, they organised and ran a Children and Families Weekend in May 2023.

Young people, parents, carers, and grandparents all came together for fun, worship and community-building at the Atholl Centre in Pitlochry, Perthshire. The theme for the weekend was 'Peace at the heart', inspired by the **travelling exhibition** that later called in at the Scottish Parliament.

The weekend helped build connections and foster honest sharing among age groups. We heard continuing support for young Friends' Summer Shindig and a clear understanding of the principles of the 'Peace at the heart' exhibition, plus potential new venues for its tour.

Friends were made and bonds developed across the vast geographical distances of Scotland. The weekend really strengthened our all-age Quaker community. We can't wait for the next one!

Grant-giving programme the circle of giving and receiving

Our grants help Quakers act on their concerns. They support Friends facing hardship, help develop their skills, and relieve suffering in the wider world. It's crucial that our grants respond to the needs and circumstances of the modern world and offer support to diverse groups of Friends in Britain.

One of our 'Living adventurously' grants funded a young Friend to live in Paris for a year. There he worked with Utopia 56, a refugee organisation. He had felt led to do this work after working with refugees in his home town in the UK.

But while the UK receives 34,000 asylum applications each year, France deals with 120,000. So, that was where he felt he needed to go to make the most difference.

He was faced with making tough decisions as to who should get the meagre resources on offer to refugees. And though he struggled at times with the relentless emotional tempo of frontline work, he was able to help those in dire need:

The experience was tough but rewarding. I learned a lot and met some amazing people, building relationships with them in order to win their trust. I would never have been able to do this without the grant – it gave me the flexibility to help out for a long period and to commit fully to the work of the organisation.

Peacebuilding in East Africa securing children's rights in Rwanda

We work with local partners to build a grassroots peace and social justice movement in East Africa. The Turning the Tide programme supports activists in Kenya, Rwanda and Burundi as they teach communities how to use active nonviolence to challenge corruption and abuses of power.

In 2022 members of a community in Rwanda's Bugesera District began tackling a serious case of child labour and exploitation, driven by local corruption. Despite child labour being illegal in Rwanda, 59 children had dropped out of school and were being paid a pittance to carry heavy sugarcane on their heads up steep hills.

But thanks to a community-led campaign supported by Turning the Tide Rwanda, 42 of the children are no longer engaged in this back-breaking work and are safely back in school. Campaigners are now visiting local sugarcane plantations in secret and reporting back. And a secure information channel has been established to continue monitoring the situation.

Turning the Tide Rwanda tells us that the community has been bolstered by its campaign successes. It has resolved to continue its campaign until the exploitation has stopped and all of the children are back in school.

This campaign raised awareness of children's rights among members of the community. It taught them about the illegal work their children were doing instead of going to school and led the community to join hands to stop this violence.

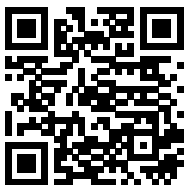
What does being a Quaker mean to you?
