2024.082 Worship and memorial minutes

We have observed a period of stillness during which we heard parts of the memorial minutes for our Friends Joy Evans, of Warwick Local Meeting, and Ruth Sutton of Cotteridge Local Meeting who died on 24th July 2024 aged 75. Both memorial minutes are printed in the Area Meeting papers.

2024.084 JYM Reports

We heard from one of the young CEQ Friends, Edith, about their experience at this year's Junior Yearly Meeting (JYM), held from 26th-30th July at Friends House. Their written reports are included in the Area Meeting papers.

We thank our Friends for their insightful and inspiring reflections. We also note that Edith is on the arrangements committee for JYM 2025, to be held in May, and ask Friends to hold her in the light during this process.

2024.085 Reflections on the Morning's Workshop

This morning, 25 Central England Quakers took part in an all-age workshop led by Mel Cook, Quaker Life Development Worker for Children, Families and Young Adults. We were joined by two Friends from Worcestershire and Shropshire Area Meeting.

The workshop was titled "Building Community: we are stronger when we know each other". We certainly did get to know each other more during this session, with lots of laughter, storytelling and creativity. It was lovely to have young friends joining in and interacting with other friends of all ages. As Mel, the facilitator, said, often people feel that they don't have the experience or skills to engage with children in meetings but it's not rocket science. We just need to be ourselves.

Mel also highlighted a new BYM resource called The Welcome Box for Local Meetings to create and welcome children, young people and families visiting meeting for the first time. Leaflets are available and the resource will be available online soon too.

2024.086 Response to the Riots

Since we last met in July, a series of riots driven by racism, anti-migrant rhetoric and disinformation has taken place across the country. The CEQAM clerks felt called to share Quaker resources available to those wishing to respond or reflect on these events.

The Toolkit for Action "engaging with conflict and challenging hate" produced by Quaker Peace and Social Witness has many ideas for reflecting on and responding to hatred and violence, and a link to download it is printed in the AM papers.

Quakers in Britain are launching a new Quaker Peacebuilding Network for Quakers, and Friends are invited to join the network.

At the September meeting of the BYM Racial Justice Network, the focus was on the recent riots in England and Northern Ireland and Alister Fuller (Quaker Life) invited Friends in the Network to consider a number of questions. CEQ's Responding to Racism Recognised Group suggests that CEQ Friends explore these questions as individuals, in small groups or within Local Meetings.

- How did this "land" with you, and in you?
- How did you respond, in your heart, in your life, individually, as communities?
- What might we do to help shape what happens next? What do we feel needs to change? What is our work in that?
- What can we be hopeful about?

We have heard that Selly Oak Meeting approached their local Al Mahdi group and took them some flowers, they also made contact with their new MP and supported him in his efforts to develop positive community relations.

It was suggested that the relative lack of incidents in Birmingham was partly due to the amount of good interfaith work done behind the scenes in very many ways. Those Friends with interfaith connections experienced a turbulent time. We were pleased that the interfaith walk organised by Footsteps and hosted by BGR was such a success with some 50 people attending, at a very crucial time.

The Conversation Café held at Warwick Meeting decided to continue with a picnic for café regulars and their families, despite the council cancelling one in the local park.

Coventry Meeting had two room lets (involving support for asylum groups and refuges) cancelled, but both returned after a break.

2024.087 The Future of Peace Hub: a 10 year review

On behalf of the Peace Hub Management Committee, the CEQ Peace Hub Coordinator, Pete Doubtfire, has shared a paper outlining the Committee's plans for the Hub's second decade of working to build an inclusive community active on matters of peace and justice.

The plan is to focus on the Hub's biggest strengths, which lie in three areas:

- Working with and supporting other groups committed to peace and social justice through outreach, inreach and networking
- Organising peace events and activities that build on this partnership work
- Taking people on a journey from passive to active in this peace work

The Committee believes that these priorities are best served by laying down the drop-in model whereby the Hub is open to members of the public at certain times of the week. This change has implications for the future of 41 Bull Street, which currently houses the Hub and the Peacemakers office, although the building could continue to provide office space for the Coordinator once the public-facing element ceases at the end of 2024.

The Peace Hub Management Committee is working with the Coordinator and the CEQ Principal Officer to develop these plans and will bring a proposal to Area Meeting in November for discernment. In the meantime, Friends are asked to consider this paper and share any feedback with Pete Doubtfire, Peace Hub Coordinator.

2024.088 Children and Young People's Committee Report

We have received a very comprehensive report from the Children's and Young People's Committee, which comprises members from three Local Meetings, a member of the CEQ safeguarding team and the Local Development Worker. The Children and Young People's Advocate from Worcestershire and Shropshire Area Meeting has also started coming to the meetings, which has been a positive experience.

Currently five Local Meetings have children and young people associated with them, and their individual activities are described in the report. In addition, there have been a number of exciting events for children and young people across the Area Meeting including a canal boat trip and a trip to Conkers Discovery Centre, with a residential family weekend at Barnes Close near Bromsgrove planned for February 2025.

The Youth Group has continued to meet monthly, attended by around 10 young people from five Local Meetings (see report for details).

Representatives from CEQ attended Senior Conference (for 15 to 18 year olds) and Junior Gathering (for 11 to 14 year olds) and we have enjoyed reading their reports.

The Committee would welcome additional members, ideally some Friends who are not parents of children and young people.

The Committee has spent time this year considering whether a paid Children, Youth and Families worker would be a positive step forward, and we have received a very detailed proposal setting out the background, reasons, benefits and what is happening in other parts of the country. An indicative cost for a full time post is £50,000 per annum.

We have been asked to discern:

- Do we feel led to engage a Children, Youth and Families Development Worker as laid out in this proposal?
- If so, for how long would we want the initial post to be in place for, bearing in mind that relationship building of the kind needed takes time? When can the Area Meeting Treasurer, in consultation with CEQ Trustees and Principal Officer, report back to Area Meeting about the financial implications of creating this role?
- Do we have a different vision for a paid worker?
- How else might we develop as an all-age community? How else can we better support children, young people and families within CEQ and the Local Meetings that welcome them?

A question was asked about the possibility of sharing the resource with another Area Meeting, but the workload involved might make this difficult.

We ask Local Meetings to consider the above questions and share their responses by the end of October. Trustees hope to be able to comment on the financial implications as part of the budget process this autumn, reporting to Area Meeting in November.

We thank CYPC for their report and know that the existing activities are greatly valued by those taking part.

2024.089 Quaker Gardens Project 2024-5

We have received a report from the CEQ Climate Action Group about their Quaker Garden Project 2024-5, included in the Area Meeting papers, and one of the group's convenors, Virginia Wollaston, gave a presentation about the project during Area Meeting.

The Quaker Gardens Project aims to explore the gardens and green spaces attached to Meeting Houses within CEQ across the seasons and considering provision for nature and rewilding as well as the stories behind them. Each Local Meeting will receive a questionnaire to identify plants and features of interest before a photography team visits the site during a specific season. Local Meetings will then be invited to provide text to accompany the images in the final document, which will be issued as a calendar too. The team would welcome feedback on optimum calendar size.

This text will follow a format that allows the project to explore the different roles that gardens and green spaces play in our Quaker meetings, both as a site of memory and identity and in support of our testimony to sustainability.

We thank our Friends who are involved in this project and look forward to seeing the results in due course.

2024.090 How the Truth has Prospered at Stourbridge Local Meeting

We have received a report from Stourbridge Local Meeting about how the Truth has prospered over the last 12 months. The full report, included in the Area Meeting papers, is organised into sections that illustrate the different ways in which meetings can nurture and be nurtured by the Truth: spiritual development, communications and social events; the children's group; faith in the community, faith in action; outreach; sustainability; projects. The report also demonstrates that meetings can build meaningful relationships with local communities and communities elsewhere in the world.

2024.091 Friends Acting Under Concern

There are no new updates regarding Friends acting under concern. We note, however, that a number of Friends from CEQ took part in a Peace Pilgrimage between Malvern and Telford from 9th-14th September 2024.

The SDSC arms fair will be held again at Telford International Centre on 18th, 19th and 20th November 2024. The trial of four Friends from CEQ for action at this event in 2023 is now set for 20th January 2025. 2024.092 Sibford School GM Report 2024

We have received a report from Julia Furminger (a former pupil) on her attendance as our representative at Sibford School's General Meeting on 15th June.

Sibford started the 2023/2024 academic year by welcoming a new head teacher, Rebecca Evans, who came with a wealth of experience and is taking a fresh dynamic approach to the school. Her focus has been on six key aims which are set out in the report.

Academically it was a successful year. Sport, Music and Drama play a big part in the school's life with many excellent outcomes.

Julia reports that the future looks exciting however there will be tough decisions to be made. Overall costs are rising and the potential of VAT being added to fees is a concern.

Sibford Old Scholars Association is struggling and the head would like to see this improved.

It was Sibford's Celebration Day on the day of General Meeting, so those attending the GM were invited to join visitors, pupils, parents and staff in the Celebration Day giving them the opportunity to see the less formal side of Sibford life.

2024.097 Northfield Meeting House September 2024

CEQAM Trustees and the CEQAM Trustees Property Committee have shared a minute regarding the tenancy at Northfield Meeting House. This comes in response to our Friend Janet Blann selling the Quaker preschool that currently occupies the building and a request from the potential new owners to have longer opening hours, including in school holidays, and exclusive use of the property. The minute reads:

T24.08.06-05 Northfield Meeting House

Property Committee held an additional meeting on 1st August to consider a request from a nursery provider who are considering buying the Quaker Pre-school business at Northfield, specifically, they would want to have longer opening hours, all year round. Property Committee recommend to trustees that they should enter into negotiations with Kayleigh and Ellie Driscoll who wish to open a day nursery called Precious Times at Northfield Meeting House, with a full repairing lease, with the nursery opening for longer hours throughout the year, which is an extension from the hours and term time use only of the current licence.

Trustees recommend this request and send this minute to Area Meeting Clerks for consideration at September Area Meeting.

We agree with this request and ask CEQAM Trustees to enter into such negotiations.

2024.098 Trustees Annual Report and Accounts for 2023
